

The City of Lakewood is more than just a satellite political subdivision to Denver. It is a well-knit, wellestablished, well-regarded community that has its own character and sense of civic pride. More than that, Lakewood has state legislative priorities that are distinct from the smaller municipalities to the north and west and the unincorporated areas to the south. That should be a strong consideration in your decision making around our legislative representation.

Lakewood is the largest city in Jefferson County, a hub for new energy and technology companies and organizations. Our city is home to more than 150,000 residents and covers 44 square miles. Surrounded by several leading universities and research facilities, Lakewood has one of the most highly educated workforces in the country, with 36 percent of our residents holding a bachelor's degree or higher.

Lakewood is the fifth-largest city in Colorado. Our nearest neighboring cities and towns are far smaller with Wheat Ridge ranking 29th, Golden ranking 37th, Edgewater ranking 109th, and Morrison ranking 291st. Lakewood is also the most diverse city in Jeffco with nearly 1/4 of its population coming from the Latinx community and a small-but-growing Asian community.

The suburbs at the foot of the Rockies certainly have many things in common, and we collaborate to advocate for certain policies, especially at the federal level. But when it comes to state policy issues, we most frequently work directly with our own legislators. That's because Lakewood's issues look more like a big city's than a small town's. We have a far larger police force, as well as higher rates of law enforcement interactions and homelessness. Our police chief has been able to effectively communicate with our legislative delegation on everything from police accountability to arrest standards to broader criminal justice reform policies — all matters that are in our headlines and our state's lawmaking process. The issues our law enforcement officers face on the Sheridan and Colfax corridors are pretty different from what some of our neighboring suburban cities face.

Affordable housing has been a serious problem in Lakewood for as long as I've served in the city government. We have our own housing authority that works closely with our legislators on housing policy issues, whereas many other Jeffco cities rely on the Jefferson County Housing Authority.

While many Jeffco cities are thought of as bedroom communities, Lakewood is the home to a significant number of primary jobs. Not only is Lakewood home to 26 federal agencies on or near the Federal Center campus, making up the largest concentration of federal agencies outside of Washington, D.C., but we're also a growing hub for new energy and technology companies, like Terumo BCT, and other long-standing Lakewood companies like 1stBank.

In addition, Lakewood is home to the major commercial corridors of West Colfax Ave., West Alameda Ave. and Union Blvd, located entirely within the city. These corridors are important economic drivers for Lakewood and part of the city's unique identity, distinguishing it from smaller suburban communities and unincorporated areas.

I hope these numerous examples paint a picture of the many ways that Lakewood's issues are distinct from those of Jeffco's smaller suburban cities and unincorporated areas, and while we indeed work

together on many things, our work with the State Legislature is most often organized through the city's leaders talking directly with our legislators. As such, it is our request that you consider Lakewood to be a community of interest, not just a compact political subdivision. Lakewood should have Senators and Representatives who see themselves as Lakewood legislators because the majority of their constituents are Lakewood residents. Please don't fracture Lakewood such that some of our legislators only have small fractions of their districts in Lakewood.

Thank you for your consideration. We know there are many competing criteria and that there's no perfect way to meet every one of them, so we hope you prioritize Lakewood's community of interest when you approve maps later this year.




Jefferson County Regional Footprints

Dear Members of the Independent Legislative Redistricting Commission,

As the largest affordable housing developer in Lakewood, Metro West Housing Solutions, Lakewood's Housing Authority, strongly advocates for a redistricting plan that allows the City to be represented in no more than two House Districts and no more than two Senate Districts — each including majority populations of Lakewood residents. This would ensure Lakewood's interests and issues will be tirelessly advocated at the State Capitol.

Gentrification within the City of Denver has driven people who still want the amenities of city life toward Lakewood, which is the fifth-largest city in Colorado. Such amenities include mass transit (light rail) which is not offered in our neighboring cities of Morrison and Edgewater. Lakewood is an established suburb but offers an abundance of open space amenities, multiple restaurants, theaters, cultural centers, an arts district, and a multitude of shopping choices.

The City of Lakewood has an estimated population of 160,441, a change of +12.39% since the 2010 census and that growth shows little sign of slowing. Lakewood's proximity to Denver means its representatives must address urban issues such as increased crime rates, a severe lack of affordable housing and increased homelessness. Currently we have 4,645 applications for affordable housing on our waiting lists. Average rents in Lakewood have increased dramatically resulting in one-bedroom unit rents starting at \$1,300, 2-bedrooms at \$1,600 and 3- bedrooms at \$2,186. High rents and lack of affordable housing are further exacerbated by the Residential Growth Limitation passed in 2019, creating even more unique issues for Lakewood including a severe lack of affordable and/or desirable land to develop affordable housing. That has resulted in higher rent for employees of Lakewood's businesses, increased traffic due to commutes from surrounding cities, and a drastic surge in homelessness.

In order to effectively address the needs of Colorado's fifth-largest city, we need representation at the local, state and federal levels that is focused on its unique needs and challenges. I urge you not to make Lakewood an answer to some other district's population needs but to allow it to have ardent proponents in all state and federal legislative bodies.

Mr. Chairman, Madam Chair, Commissioner members,

Thank you for your time this evening. My name is Lisa Johnson and my wife have been residents of Jeffco for 10 years.

I am here tonight because I have concerns regarding the redistricting of Jeffco. I would like you to consider keeping Jefferson county whole **as is** on the congressional map by keeping Arvada and the surrounding areas in Jefferson county.

I am here to makes sure "Community of interest" is upheld in Jeffco. Jeffco shares substantial interests with Arvada and the surrounding areas including but not limited to: they are composed of a reasonably proximate population, and thus should be considered for inclusion within a single district for purposes of ensuring its fair and effective representation.

When considering the redistricting of Jefferson county, equal population and the voting rights act **must** be the way we draw our county lines. I strongly disagree with splitting up Arvada into two state senate districts and three house state senate districts. I believe this would only break up a growing, vibrant area of Jefferson County. Currently, Jeffco has approximately 550,000 people and the 2021 Congressional district is composed of approximately 700,000 residents. A way we could make up the approximate 150,000 constituents would be to keep Jeffco whole by keeping *Westminster, Arvada, Broomfield as well as Gilpin in Jeffco.

If the committee decides to exclude Arvada from Jeffco it would be breaking up a single school district, a single public health system and a single safety system. Cutting out a large portion of the city of Arvada from Jeffco would be a miscalculation by this commission because the county would lose a large portion of their growing population and would also lose the important minority demographics in Jeffco. I strongly believe that Arvada should remain in the 7th CD.

As a member of the LGBTQ community, keeping Jefferson county whole is a huge concern of mine. I like to believe that Jefferson county has continued to become safer and more family friendly to the gay community. There is an unmistakable contrast between Arvada and the demographics of Northwestern part of Douglas

county when discussing the safety and inclusion of LGBTQ members. Not only is the gay community underrepresented in the south but the LGBTQ community faces discrimination in Douglas county. I have personally been discriminated against when shopping in that area by being followed, harassed, I have experienced hateful slurs and a heil Hitler hand sign for simply holding my wife's hand in public. I want to live in a county where my family and friends feel included and I am not in constant fear of retaliation from the hate I have experienced in that area.

I consider the city of Arvada and surrounding areas to be our neighbors and we share the same values, resources, school systems and infrastructure, not to mention that our local businesses rely on their well-built relationships that they have with other businesses within our county.

Northwestern Douglas county shares a culture which is more aligned with more rural parts of the state and I do not believe including this area into Jefferson county would be the correct decision. Northwestern Douglas county would be better served by keeping Douglas county whole and giving that area a chance to grow. The northwestern part of Douglas counties population is vastly smaller at 75,452 residents compared to Arvada which has a population of 106,433 residents. It does not seem right to divide our county and bring in new areas that do not share our sense of community.

The powerful relationships that have been curated within, the current county lines, is a part of what makes living in foothills of Jefferson county so special.

I hope Jeffco continues to move forward together instead of going backwards and dividing us.
